NCDMV Appointment Confirmation

To combat people not showing up for their scheduled appointments at driver license offices, the N.C. Division of Motor Vehicles is now requiring new appointments to be confirmed.

Now, when appointments are reserved online at SkipTheLine.ncdot.gov, customers will immediately receive a text message and email with a confirmation link and will have 15 minutes to respond.

Four days before the appointment, customers will receive a reminder text and email with a confirmation vehicle, never drink and drive and use extra caution when traveling through work zones. link. This time, they will have 24 hours to click the link to confirm their appointment.

Johnston County Highway Requires Closure for Drainage Improvements

FOUR OAKS – A section of U.S. 301 on the outskirts of Four Oaks <u>has closed</u> to through traffic for about seven weeks to allow an N.C. Department of Transportation contract crew to replace a drainage pipe under the pavement.

A Wilson Street Requires Closure for Drainage Work

WILSON – A section of Nash Street near downtown Wilson is closed for drainage improvements. State maintenance crews are replacing pipes with larger culverts that will improve the flow of water underneath the roadway at these three Nash Street intersections:

ARCHER LODGE – The Covered Bridge Road spanning over Buffalo Creek in northern Johnston County will close starting Monday for reconstruction.

A contractor for the state Highway Department will replace the bridge, built in the 1970s, near Prestwood Lane with a wider, two-lane span.
